

**OUTLET COLLECTION WINNIPEG "May Long Weekend - Shop & Stay Contest"  
(the "Contest")**

**RULES AND REGULATIONS**

NO PURCHASE NECESSARY. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO COMPLETE YOUR ENTRY YOU MUST READ AND AGREE TO THE FOLLOWING TERMS. PARTICIPATION IN THIS CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE CONTEST RULES. ALL DOLLAR AMOUNTS ARE IN CANADIAN FUNDS (\$CDN) UNLESS OTHERWISE NOTED.

**(1) CONTEST PERIOD (the "Contest Period"):** The Contest begins at 10:30 AM (CST) May 13, 2019 and ends at 11:59 PM (CST) on May 16, 2019 (the "Contest Closing Date").
